**ORDER:**

In the Government order 3<sup>rd</sup> read above, based on the recommendations of the First Pay Revision Commission, orders were issued implementing the Revised Pay Scales, 2020 to the State Government employees.

2. Government in the reference 1<sup>st</sup> read above, issued orders fixing the remuneration of Rs.125/- per day to the Drivers of the Government Vehicles, Roneo Duplicating Operators and Lift Operators of all the Government Departments who are drawing pay in Revised Pay Scales, 2015 and are required to perform official duty on a public holiday and who could not be sanctioned a compensatory holiday in lieu thereof.

3. The First Pay Revision Commission inter alia has recommended for enhancement of the remuneration payable to the regular Drivers of the Government Vehicles and Lift Operators of all the Government Departments @ Rs.150/- per day.

4. Government, after careful consideration of the recommendations of First Pay Revision Commission and in modification of the orders issued in Government order 1<sup>st</sup> read above, hereby order enhancement of the remuneration payable to the Drivers of the Government Vehicles and Lift Operators of all the Government Departments, who are drawing pay in the Revised Pay Scales, 2020 and are required to perform official duty on a public holiday and who could not be sanctioned a compensatory holiday in lieu thereof to Rs.150/- per day. The form of certificate prescribed earlier may be continued to be insisted to be furnished by the concerned controlling officer as shown in the Annexure.

5. Government also hereby order that in respect of Drivers performing duties on a public holiday exclusively on account of a private work of an Officer, the remuneration of Rs.150/- per day be paid by the Government in the first instance and later on the same shall be recovered from the Officer concerned along with the Propulsion Charges payable by the Officer.
6. These orders are not applicable to those Drivers who are on a tour outside the Headquarters as they are paid Travelling Allowance and Daily Allowance for the holiday, while on tour.
7. These orders are applicable to all the regular Drivers and Lift Operators of Government Departments and Local Bodies including Zilla Grandhalaya Samsthas and Agriculture Market Committees, drawing Revised Pay Scales, 2020.
8. All the Departments of Secretariat, Heads of Departments and all respective controlling officers are requested to certify and make entries in the log book maintained by the Drivers of the Vehicles. The amount may be claimed in Telangana Treasury Code Form-58, i.e., Fully Vouched Contingent Bill. The Controlling Officers will have to append a certificate as shown in Annexure, appended to this order, to the Bill, in which the claim is preferred.
9. The expenditure on account of payment of Compensatory remuneration shall be debited to the detailed head '130 Offices Expenses - 132 Other Office Expenses' under the appropriate Major, Minor and Sub-head of Account of the concerned Department. In respect of local bodies including Zilla Grandhalaya Samsthas and Agriculture Market Committees, the expenditure shall be met from their own funds.
10. Government, hereby order to discontinue the provision for payment of remuneration payable to the Roneo Duplicating Operators for attending to the Official duties on holidays.
11. These orders shall come into force with immediate effect.
12. Necessary amendments to the Telangana Manual of Special Pays and Allowances shall be issued in due course.
