ORDER:

In the Government Order 3rd read above, based on the recommendations of the First Pay Revision Commission, orders were issued implementing the Revised Pay Scales, 2020 to the State Government employees.

The First Pay Revision Commission inter alia has recommended for enhancement 2. of eligibility ceiling for the existing conveyance allowance to various categories of employees as detailed in Annexure-III of the Manual of Special Pays and Allowances, as amended from time to time, in the Revised Pay Scales, 2020.

Government, after careful consideration of the recommendations of the First Pay 3. Revision Commission and in modification of the orders issued vide reference 1st read above, hereby order for enhancement of eligibility ceiling for the existing conveyance allowance in the following pattern, to various categories of employees as detailed in Annexure, appended to this order;

- a) The existing rate conveyance allowance which is subject to maintenance of Motor Car or a Motor Cycle is increased from Rs.1,050/- to Rs.1,500/- (Rupees fifteen hundred only) per month
- b) The existing rate of conveyance allowance which is subject to maintenance of Bicycle is increased from Rs.300/- to Rs.500/- (Rupees five hundred only), per month.

4. The conveyance allowance will not be applicable to the employees who are provided with Government/Hired vehicles. The concerned Administrative Department/ Head of Department/ District Authorities should issue an order to the effect that the employees are not provided with such vehicle facility to become eligible for the conveyance allowance. The orders shall be issued or renewed whenever necessary.

5. Conveyance Allowance for Blind, Hearing Impaired and Physically Handicapped employees:

As per the recommendations of the First Pay Revision Commission, Government hereby order that the conveyance allowance shall be paid at 10% of the basic pay, subject to a maximum of Rs.3,000/- per month to the Blind, Hearing Impaired and Physically Handicapped employees. All other conditions regarding eligibility, procedure etc., shall remain unchanged.

6. These orders shall come into force with immediate effect.

7. Necessary amendments to the Manual of Special Pays and Allowances will be issued in due course.
