- 1. Name of the Award** : PJTSAU Best Polytechnic Award
- 2. Sponsor of the award** : PJTSAU
- 3. Objective of Award** :

1. To recognize the outstanding performance of the constituent Polytechnic
2. To provide incentive for outstanding Polytechnic.
3. To provide a sense of pride in achievements.

- 4. The Nature of Award** : The award consists of a citation and a plaque.
- 5. Frequency of award** : Every year
- 6. Eligibility criteria** :

The Polytechnics under PJTSAU (only University Polytechnics) are eligible to apply. The Polytechnic applying for the award must be in existence for atleast past five years. The award winning Polytechnic shall not be eligible to apply for this award for next five years.

**7. Presentation of the Award:**

The presentation shall be made on the foundation day of the University i.e., 3<sup>rd</sup> September of every year.

  10. Give the major highlights of the accomplishments in 200 words that could be incorporated in the citation if chosen for the award.
  11. Certificate and forwarding note of Head of Institution stating that the Polytechnic did not get this award in past 5 years.
