- Supporting the investment process by conducting due diligence and other related legal and financial compliances.
- coordination with due diligence agencies- legal and CA firms and other external entities as needed.
- Post investment coordination, portfolio monitoring and management, appraisal to the board on portfolio performance.
- Angel affiliations- with angels, angel networks and VC's for follow on funding mechanisms.
- Create an exit mechanism for the successful exits from invested portfolios, based on portfolio performance.
